SUBJECT: Notification of Intent (NOI) to issue an Invitation for International Bidding (IFIB) for the Provision of Backup Systems to STO Centre for Maritime Research and Experimentation (CMRE).

Title of IFIB: Backup Systems.

Requirement: *CMRE requires an enterprise-grade data storage and backup system. Storage is being standardized on all networks and a suitable backup solution that can scale to cover the big data holdings produced by CMRE need to be implemented. The requirement is for a Dell-EMC2 turnkey scalable backup solution, with integration with the existing Cisco/Dell-EMC2 Data Centre, VMWare virtualized environment, and EMC2 storage systems already in use.*

Type of Contract: Firm Fixed Price (FFP).

Bidding Procedure: Sealed bid (no negotiations).

Award Method: Lowest Priced Technically Acceptable (LPTA) bid.
